

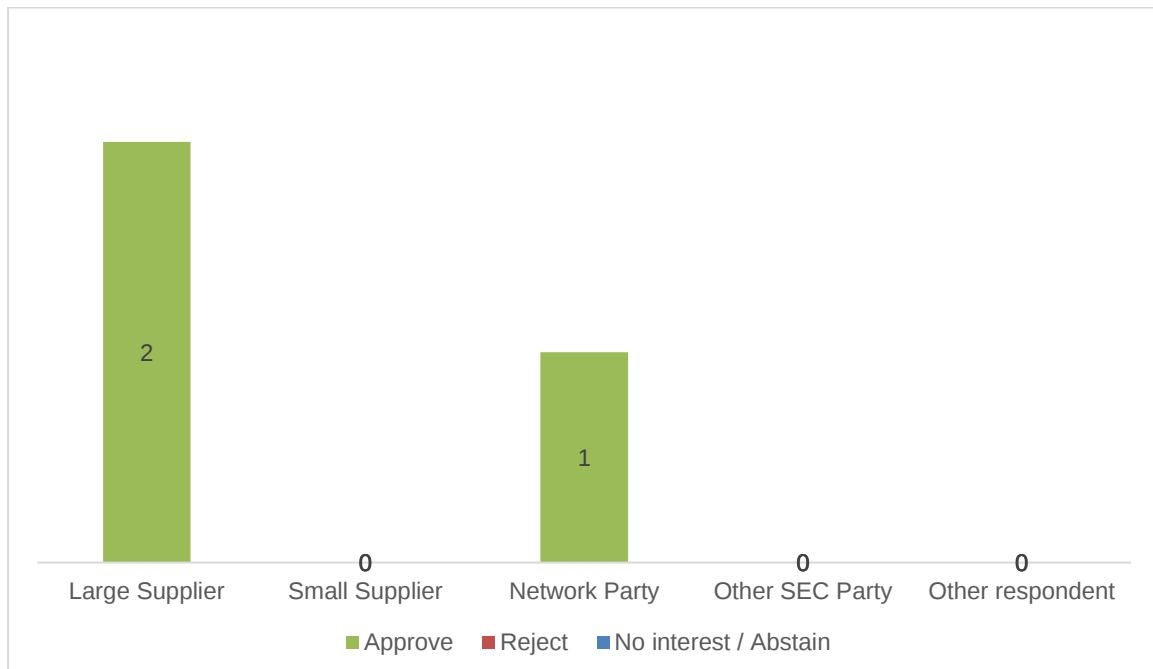

However Interface Testing and Systems Integration Testing definitions still reference Section T1.	Thank you for your comments, SECAS will amend the legal text and publish v1.1 ahead of the December 2022 Change Board.

EDF	Large Supplier	SECTION A The updated definitions for 'Interface Testing' and 'Systems Integration Testing' have references to Section T1, which will no longer be available going forwards. Interface Testing means the testing that tests the capability of the DCC and the DCC Systems together with the Communications Hubs selected pursuant to Section T1 to interoperate with User Systems described in Section T3 (Interface Testing). Systems Integration Testing means the testing described in Section T2 (Systems Integration Testing) that tests the capability of the DCC and the component parts of the DCC Systems together with the Communications Hubs selected pursuant to Section T1 to interoperate with each other and with the RDP Systems. SECTION D D10.19 – The original wording included the requirement for costs to be included, however in the new more detailed list of minimum content	Thank you for your comments, SECAS will amend the legal text and publish v1.1 ahead of the December 2022 Change Board.
