Decision Items

TABASC_41_1804 - Draft Minutes and Actions Outstanding (For Decision)

The draft minutes from the April 2019 TABASC meeting were approved as final. All actions were marked as completed or on target for completion with several verbal updates provided.

TABASC_42_1605_03 - Potential Letter to Panel (For Decision)

The TABASC **AGREED** to re draft the letter regarding Market-wide Half Hourly Settlement (MwHHS) to the SEC Panel to include the TABASC input.

TABASC_42_1605_10 - Draft TABASC Work Package July - September 2019 (For Decision)

The TABASC **AGREED** to recommend the Work Package for SECCo Board approval, noting the update required as a result of deferring the work on the Effectiveness Review.

TABASC_42_1605_11 - SMETS1 Services Release BAD & TAD Project Update - April 2019 (For Decision)

The TABASC **AGREED** an approach to the approval of the Business Architecture Document (BAD) and Technical Architecture Document (TAD) prior to final publication and to re-baseline the projects.

TABASC_42_1605_15 - TABASC Risk Register (For Decision)

As part of the TABASC Risk Register review, the TABASC **AGREED** minor amendments to the existing five mid-tier risks.

BEIS Electric Vehicle Feasibility Studies Update (Presentation)

This agenda item was postponed to the June 2019 TABASC meeting.

DCC Ecosystems Management Framework Update (Presentation)

DCC provided the TABASC with an update on the Ecosystems Management Framework highlighting that they are conducting a pilot with a Supplier to prove the benefit.

DCC T3 Aerials Update (Presentation)

DCC provided the TABASC with an update on T3 Aerials highlighting updates are due in autumn. DCC agreed to provide regular updates and to try to expedite the work.

DCC LTE Communications Hubs Update (Presentation)





DCC provided the TABASC with an update on the LTE Communications Hubs highlighting updates are due in autumn. The DCC agreed to provide regular updates and noted the need to expedite this work.

The TABASC provided comments on the proposed scope on the June 2020 and November 2020 SEC Releases and on the draft June 2020 SEC Release Implementation Document.

Effectiveness Review Questionnaire (Presentation)

SECAS provided the TABASC with a presentation on the Effectiveness Review Survey highlighting that there is a proposed new format for the third iteration of the Effectiveness Review Survey, which will be provided to the TABASC for comments due at the June 2019 meeting.
