## Change Board vote

### Change Board decision

The Change Board voted to **approve** MP073 under Self-Governance.

### Views against the General SEC Objectives

#### Objective (a)<sup>1</sup>

A minority of the Change Board members believe that MP073 will better facilitate SEC Objective (a) by ensuring that Eligible Subscribers and Relying Parties can rely on the integrity of the information contained in the Smart Metering Key Infrastructure (SMKI) Repository which is required to support Smart Meter Installation and Change of Supplier. The remaining members were neutral against this objective.

#### Objective (f)<sup>2</sup>

The Change Board believe that MP073 will better facilitate SEC Objective (f) by ensuring the protection of Data and the security of Data and Systems in the operation of this Code by providing effective SMKI Services facilitated by the SMKI Repository and ensuring the SMKI Repository is accurate and reliable.

#### Objective (g)<sup>3</sup>

A minority of the Change Board members believe that MP073 will better facilitate SEC Objective (g) though efficient and transparent administration and implementation of this Code by providing clear guidance and effective governance for the DCC and for DCC Users who rely on information contained within the SMKI Repository. The remaining members were neutral against this objective.

## Comments and discussions

### Consultation responses

All four responses received to the Modification Report Consultation were in support of the proposed solution in MP073. Rationale given was generally that this modification would better facilitate the SEC Objectives, especially SEC Objective (f). There were some comments that the Proposer of MP073 was overreaching on the SEC objectives they are claiming it facilitates.
