SECPMA_65_2101 - Meeting Highlights

At each meeting, the Smart Metering Key Infrastructure Policy Management Authority (SMKI PMA) receives updates from the DCC, BEIS and other Sub-Committees on matters of relevance to the SMKI arrangements.

This month, the SMKI PMA was presented with the following items:

DCC Operational Recovery Procedures for Users (GREEN) (*DCC*) The SMKI PMA noted that the DCC has produced guidance on DCC Operational Recovery Procedures for Users, as required by SEC Appendix L, Section 4.

SMKI Standards and Guidance Review (GREEN) (*SMKI PMA Chair*) The SMKI PMA considered options to replace SEC references to the discontinued or changed Good Practice Guides (GPGs) 13, 43, 45 and 46 as set out by the National Cyber Security Centre (NCSC), and agreed to adopt bespoke guidance based on the security principles set out in the GPGs and other available guidance but focused on Smart Metering; a SEC Modification will be raised to update the SEC guidance references.

TABASC Effectiveness Review (AMBER) (SECAS) The SMKI PMA was presented with the results of the Effectiveness Review carried out by the Technical Architecture and Business Architecture Sub-Committee (TABASC) in September 2019 which included the actions that will be taken by SECAS to address the feedback.

SMKI Recovery Exercise Costs (RED) (*DCC*) The SMKI PMA was presented with an analysis of costs by the DCC from the SMKI Recovery Exercise which took place in July 2019.

New Draft Proposals and Modification Proposals (SECAS) The SMKI PMA noted updates on the following Draft Proposals and Modification Proposals:
