



			We prefer the Proposed Solution as the main function of the SEC is to act as a bilateral agreement between the DCC and the Users of its services. The Alternative Solution would seem to give disproportionate representation to SEC Parties that are not DCC Users, noting that these Parties are able to actively engage with SEC governance through other routes, such as the Sub-Committees.
