### Question 1: Do you agree with the solution put forward?

EDF	Large Supplier	No	We agree that Large Gas Smart Meters should not be subject to the display requirements currently set out in SMETS.
			We would question whether the right approach would be to exempt these meters from the display requirements entirely, given the potential impacts on consumers and on industry processes that drove the original change in SECMP0006. In order to ensure a consistent approach and minimise consumer confusion we think it would it potentially make sense to specify an alternative display requirement for Large Gas Smart Meters, rather than relieving them from these obligations entirely.





### Question 2: Will there be any impact on your organisation to implement MP101?

Respondent	Category	Response	Rationale
EDF	Large Supplier	Yes	We will need to make sure that any Large Gas Smart Meters that we might procure and install are compliant with the display requirements in the MID rather than any specification within SMETS. For consistency with other smart meters we would prefer for an appropriate display requirement for Large Gas Smart Meters to be set out in SMETS.





### Question 3: Will your organisation incur any costs in implementing MP101?

EDF	Large Supplier	No	We would not expect to incur any direct costs as a result of this change being made; we do not see this change as having a material impact on the cost of devices that will be compliant with the new version of SMETS.
