# SEC Panel Meeting 09:30 – 12:30, 17 April 2020 SECP\_79\_1704 – Meeting Headlines

## **Decision, Discussion and Information Items**

#### 1. Minutes and Actions Outstanding (For Information)

The Panel noted that the minutes from the 13 March Panel meeting had been approved excommittee. It was noted that all actions marked as Propose to Close could be closed.

## 2. Business Continuity Plans (For Information) (AMBER)

SECAS, Deloitte and the DCC updated the Panel on their Business Continuity Plans in the light of Covid-19. The Agenda Item was classified as **AMBER** and therefore recorded in the Confidential Minutes. The Panel **NOTED** the update.

# 3. Aclara IOC Decision (For Decision) (AMBER)

SECAS updated the Panel with the assessments from the Testing Advisory Group (TAG), the Security Sub-Committee (SSC) and the Operations Group (OPSG) regarding the DCC's statement of readiness against the Live Services Criteria (LSC) for additional entries onto the Eligible Products Combination List (EPCL) for the Initial Operating Capability (IOC) for Aclara Devices. The Agenda Item was classified as AMBER and therefore recorded in the Confidential Minutes. The Panel

- **NOTED** the views of the TAG and OPSG contained in this paper and the SSC in Confidential Appendix C;
- AGREED the content of the letter from the Panel to BEIS for the 'Live Services Criteria for the IOC Aclara entries onto the Eligible Products Combination List (EPCL) for SMETS1' (Appendix B); and
- **AGREED** to recommend to BEIS that the EPCL is updated subject to the condition to carry out further regression testing set out in response to outstanding Testing Issue 110031.

#### 4. Operational Metrics Review Project Recommendation (For Decision) (GREEN)

The OPSG presented the Panel with a report outlining findings of the Operational Metrics Review. This Review was commissioned by the OPSG to identify improvements in the metrics used to measure the DCC service, following issues raised in relation to the monthly Performance

Measurement report (PMR). The Agenda Item was classified as **AMBER** and therefore recorded in the Confidential Minutes. (*Post Meeting Note: The classification of this paper was changed from Amber to Green).* The Panel:

- AGREED the findings and recommendations set out in the OPSG OMR Report;
- **AGREED** the way forward, including a Modification to implement the recommendations of the report; and
- **AGREED** that the actions set out within the report for the DCC and OPSG should be carried out.

This Draft Proposal was discussed in relation to the Operational Metrics Review Project under Item 4. The Panel:

# 5. SMDA-SEC Problem Statement Consultation (For Decision) (AMBER)

Following discussions at the March SEC Panel Meeting, SECAS and the Smart Metering Device Assurance (SMDA) Scheme presented the Panel with a joint consultation, designed to seek the views of Parties on the issues raised under SEC Draft Proposal <u>DP111 'SMDA Budget Amendments'</u>. The Agenda Item was classified as <u>AMBER</u> and therefore recorded in the Confidential Minutes.

The Panel **APPROVED** that this document be issued for a 20 Working Day consultation period.

# 6. P379 Update (For Information) (AMBER)

The Technical Architecture and Business Architecture Sub-Committee (TABASC) Chair presented the Panel with TABASC concerns surrounding BSC <u>Modification P-379 'Multiple Suppliers through Meter</u> <u>Splitting'</u>. The Panel Chair issued a letter voicing these concerns to Elexon on Thursday 9 April 2020, and received a response on Wednesday 15 April 2020. The Agenda Item was classified as **AMBER** and therefore recorded in the Confidential Minutes. The Panel:

- AGREED that the impacts highlighted are cause for concern for Smart metering;
- HIGHLIGHTED further considerations; and
- **AGREED** that the Chair (PD) will contact relevant stakeholders at Ofgem and Elexon to request that they embrace Smart Metering as a mechanism to deliver the required capability.

# 8. Security Characteristics Threat Mapping Project Brief (For Decision) (AMBER)

The SSC Chair presented the Panel with the proposed approach for the Commercial Product Assurance (CPA) Security Characteristics (SC's) Review, including the project overview and approach, scope, and timeframe. The Agenda Item was classified as **AMBER** and therefore recorded in the Confidential Minutes. The Panel:

# 9. Risk and Issues Registers Update (For Information) (AMBER)

The Panel:

- **CONFIRMED** that this risk will not be added to the SEC Panel Risk Register; and
- **NOTED** the latest set of Risks and Issues contained within Annex A and B.

## 10. End of Year Regulatory Report (For Decision)

SECAS presented the Panel with a draft End of Regulatory Year Report for the 2019-20 period. This report was provided to the Panel as a confidential appendix to allow Panel review prior to wider circulation to Parties. The Panel is also required, as part of that Report, to set out its evaluation of whether the SEC continues to meet the SEC Objectives.

The Panel **AGREED** to review the End of Year Regulatory Report over five working days, with feedback due on Friday 24 April 2020.

#### 11. Current Events of Default (For Decision) (RED)

The Panel was provided with updates on four new Events of Default, one existing Event of Default, and Network Operator non-compliances. The Agenda Item was classified as **RED** and therefore recorded in the Confidential Minutes.

The Panel:

- NOTED the four new Events of Default;
- NOTED the existing Event of Default;
- AGREED to take no further action regarding the Network Operator non-compliance updates.

#### 12. Change Status Report – March 2020 (For Information)

The Panel was provided with an update on the progress of Modification Proposals going through the change process, a summary of potential future release content and the DCC Impact Assessment (IA) and Preliminary Assessment (PA) timetable. The Panel **NOTED** the report.

SECAS provided the Panel with an update on the timetables for Modification Proposals currently in the Refinement Process. The timelines presented cover the next main programme of work for selected open modifications, and the due date this is expected to be completed by. The Panel is **AGREED** to the programmes of work and timelines in this paper.
