SECPMA_68_2104 – Meeting Highlights

At each meeting, the Smart Metering Key Infrastructure Policy Management Authority (SMKI PMA) receives updates from the DCC, BEIS and other Sub-Committees on matters of relevance to the SMKI arrangements.

This month, the SMKI PMA was presented with the following items:

2. **SMKI PMA Guidance (AMBER)** (*SMKI PMA Chair*) The SMKI PMA considered recommendations from the SMKI PMA Chair regarding replacing SEC references to the National Cyber Security Centre (NCSC) Good Practice Guide (GPG) 13. Potential changes to the draft SMKI guidance were discussed, to be brought back to a future SMKI PMA meeting for approval.
3. **Amendments to SEC Appendix D – SMKI RAPP (AMBER)** (*DCC*) The SMKI PMA approved the proposed changes to SEC Appendix D – SMKI Registration Authorities Policies and Procedures (RAPP), to align the document with DCC procedures.
4. **SMKI Testing (RED)** (*DCC*) The SMKI PMA noted the update on the current status of SMKI testing plans.
5. **Certificate Policy and Certification Practice Statement for MOC and FOC (RED)** (*DCC*) The SMKI PMA noted an update on the Certificate Policy (CP) and Certification Practice Statement (CPS) for SMETS1 Middle Operating Capability (MOC) and Final Operating Capability (FOC).
6. **DCC SMKI Certificate Revocation Architecture (RED)** (*DCC*) The SMKI PMA was updated by the DCC on the DCC SMKI certificate revocation architecture.
7. **New Draft Proposals and Modification Proposals (SECAS)** The SMKI PMA noted updates on the following Draft Proposals and Modification Proposals:

In regard to MP122, the SMKI PMA requested further clarification from SECAS on the DCC solution to determine whether this Modification will impact SMKI.

8. **Supplier of Last Resort (SoLR) (AMBER)** (SECAS) SECAS provided the SMKI PMA with an update on the proposed SoLR process, with a focus on DCC enrolled Systems and customers in Pre-Payment mode, and the potential role of a Shared Resource Provider (SRP) in the SoLR process. Members agreed to discuss the SECAS proposals in detail at the next SMKI PMA meeting.
