MP115 'Changes to the NCSC Good Practice Guides' Conclusions Report

About this document

This document summarises the responses received to the Modification Report Consultation and the decision of the Change Board regarding approval or rejection of this modification.

Summary of conclusions

Change Board

The Change Board voted to **approve** MP115. It believed the modification better facilitates SEC Objectives $(b)^1$, $(f)^2$ and $(g)^3$.

Modification Report Consultation

SECAS received four responses to the Modification Report Consultation. All respondents believed the modification should be approved. They considered the modification better facilitates SEC Objectives (f) and (g), but not (b).

Modification Report Consultation responses

Summary of responses

Three Large Suppliers and one Network Party responded to the consultation. All respondents agreed that this modification would ensure the efficient implementation of the Code. They also agreed this modification would provide Parties with the most up-to-date guidance relating to the protection of Data and the security of Data and Systems when operating under the Code.

One respondent advised that without this change, it is likely that misalignments will occur between the SEC and the amended guidance

Views against the General SEC Objectives

Objective (b)

The Change Board unanimously believes that MP115 will better facilitate SEC Objective (g) by ensuring the Code is maintained in line with the SMKI PMA's and the SSC's updated and replacement guidance.
