SEC Panel Meeting 83 09:30 - 13:00, 14 August 2020 SECP 83 1408 – Meeting Headlines

Decision, Discussion and Information Items

1. Minutes and Actions Outstanding (For Information)

The Panel noted that the minutes from the July Panel meeting had been approved ex-committee. It was noted that all actions marked as Propose to Close could be closed. The Panel NOTED the update.

2. Ofgem Update (For Discussion) (GREEN)

Ofgem informed the Panel that it is developing Guidance for the DCC on how it can develop Value Added Services (VAS). The Panel AGREED to provide feedback to support Ofgem's development of an open letter.

3. MOC Secure Next Steps (For Information) (AMBER)

SECAS presented the Panel with an update on readiness to add Middle Operating Capability (MOC) Secure Device Model Combinations (DMCs) to the Eligible Products Combination List (EPCL). The Agenda Item was classified as AMBER and therefore recorded in the Confidential Minutes. The Panel **NOTED** the update.

4. Panel Response to BEIS BMPPA Consultation (For Decision) (AMBER)

SECAS provided the Panel with a summary of the BEIS consultation relating to the DCC Baseline Margin Project Performance Adjustment (BMPPA) for Enduring Change of Supply (ECoS). SECAS has proposed a draft Panel response to the consultation. The Agenda Item was classified as AMBER and therefore recorded in the Confidential Minutes. The Panel NOTED the update and AGREED the content of the draft consultation prior to SECAS issuing a response to BEIS on 14th August.

5. Supporting TSIRS with Digital SEC – Project Brief (For Decision) (GREEN)

SECAS presented the Panel with the scope of work which BEIS has requested SECAS to undertake as part of the ongoing work to support the Technical Specification Issue Resolution Subgroup (TSIRS). The Panel APPROVED the linking of the Technical Specifications in the Digital SEC to the 'Explains' in BEIS Issues Log and APPROVED the recommendation of the Project to the Board for release of funds.

6. Data Privacy Incident Report (For Information) (RED)

The DCC informed the Panel of a Data Privacy Incident. The Agenda Item was classified as RED and therefore recorded in the Confidential Minutes. The Panel NOTED the incident.

7. Random Sample Privacy Assessment Process (For Decision) (AMBER)

SECAS informed the Panel that on 28 September 2020, the Independent Privacy Auditor (IPA) will be conducting its first Random Sample Privacy Assessment (RSPA). SECAS and the IPA have therefore Managed by

developed and tested proposals for the methodology to be adopted. The Agenda Item was classified as **AMBER** and therefore recorded in the Confidential Minutes. The Panel **AGREED** SECAS' recommendations.

8. Sub-Committee and SEC Panel Survey Outcomes (For Discussion) (AMBER)

SECAS presented the Panel with the results of the recent survey issued to Panel and its Sub-Committee members, to inform our approach to hosting meetings. The Agenda Item was classified as **AMBER** and therefore recorded in the Confidential Minutes. The Panel **CONSIDERED** the outcomes of the survey and **AGREED** the proposed approach to facilitating meetings.

9. SEC Panel 2021 Meeting Dates (For Decision)

SECAS presented the Panel with the proposed meeting dates for 2021. The Panel **AGREED** to the proposed meeting date schedule for 2021.

10. Website Enhancement Project Update (For Information) (GREEN)

SECAS updated the Panel on the positive impact of changes implemented to enhance website accessibility and functionality for SEC Parties in May 2020. The Panel **NOTED** the update.

11. Current Events of Default (For Decision) (RED)

SECAS updated the Panel on two new Events of Default and one existing Event of Default. The Agenda Item was classified as **RED** and therefore recorded in the Confidential Minutes. The Panel **NOTED** the Events of Default and **AGREED** SECAS' recommendations.

12. Change Status Report – July 2020 (For Information)

SECAS provided the Panel with an update on the progress of Modification Proposals going through the change process, a summary of potential future release content and the DCC Impact Assessment (IA) and Preliminary Assessment (PA) timetable. The Panel **NOTED** the report.

13. Disclosure of Confidential Information (For Discussion)

The DCC informed the Panel that the DCC wishes to include price and cost information for modifications in its submissions to the SEC modifications Working Group, and as part of the corresponding industry consultations. Given commercial sensitivities raised by the DCC, the Panel **AGREED** that Option 3 is the best way to proceed – whereby the modification report will include cost brackets, with a separate confidential appendix being available on request.

14. SECMP0015 'GPF timestamp for reading instantaneous Gas values' – Change Board decision referral (For Decision)

SECAS (DK) informed the Panel that the Change Board voted to reject <u>SECMP0015</u> 'GPF timestamp for reading instantaneous Gas values' under Self-Governance on 22 July 2020. Subsequently, British Gas has elected to refer this decision to the Panel. The Panel **DETERMINED** that SECMP0015 should be **APPROVED** and **AGREED** to correct the proposed implementation approach for SECMP0015.

15. SEC Modification Timetables (For Decision)

SECAS provided the Panel with an update on the timetables for Modification Proposals currently in the Refinement Process. The timelines cover the next main programme of work for selected open modifications, and the due date this is expected to be completed by. The Panel **AGREED** to the programmes of work and timelines laid out in the paper.
