At each meeting, the Smart Metering Key Infrastructure Policy Management Authority (SMKI PMA) receives updates from the DCC, BEIS and other Sub-Committees on matters of relevance to the SMKI arrangements.

This month, the SMKI PMA was presented with the following items:

- 2. Cost of SMKI Recovery (RED) (DCC) The DCC provided the SMKI PMA with the updated estimated costs for SMKI Recovery. The SMKI PMA queried the costs and asked the DCC to investigate further.
- 3. Key Custodians (RED) (DCC) The DCC provided the SMKI PMA with the proposed changes and clarifications to the Nomination and Responsibilities of the Key Custodians guidance document, and Members asked the DCC to investigate the feasibility of an alternative approach regarding the safekeeping of Keys.
- **4. SMETS1 Symmetric Keys (RED)** (*DCC*) The DCC provided the SMKI PMA with an update on the SMETS1 Symmetric Keys Working Group (WG) which took place on 10 August 2020.
- 5. Lookback Report Q1 2020 (Apr-Jun) (AMBER) (SECAS) The SMKI PMA noted the lookback report against the Q1 (April June) Work Package.
- 6. Work Package Q3 2020 (Oct-Dec) (AMBER) (SECAS) The SMKI PMA recommended the Q3 2020 Work Package to the SECCo Board for approval.
- 7. MD5 Audit Identification of Environments (RED) (DCC) The DCC provided the SMKI PMA with an update on the use of hash algorithm MD5 in DCC environments, noting where and why the MD5 algorithm is used.
- 9. SMKI Testing (RED) (DCC) The SMKI PMA noted the proposed plan and progress of Phase 2 of SMKI testing and advised it approved the DCC's approach. The DCC will continue to provide the SMKI PMA with updates on SMKI testing at future meetings





- 10. DP128 'Gas Network Operations SMKI Requirements' (AMBER) (SMKI PMA Chair) The SMKI PMA Chair provided Members with an update on the proposed legal drafting solutions for DP128 'Gas Network Operations SMKI Requirements', which were previously considered by Members at the SMKI PMA 71 meeting.
- **11. New Draft Proposals and Modification Proposals** (SECAS) The SMKI PMA noted updates on <u>Draft Proposal 137 – Draft Proposal 138</u> and agreed there are no potential impacts on SMKI.
