The SEC sets out the Smart Metering Equipment Technical Specifications (SMETS). To ensure interoperability, the dates that these technical specifications can be used are set out within SEC Schedule 11 'Technical Specification Applicability Tables' (TSAT).

For a large part of 2020, the UK government issued social distancing guidance to help reduce the transmission of COVID-19 meaning only essential meter installations were able to take place. If the existing Installation Validity Period (IVP) end-date of 27 April 2021 for pre-version 4.2 SMETS2 Devices remains as is, and the reduced speed of installations continues to take place, then thousands of Devices would be scrapped.

Change Sub-Committee decisions


