SMKI PMA_80_2004 – Meeting Highlights

At each meeting, the Smart Metering Key Infrastructure Policy Management Authority (SMKI PMA) receives updates from the DCC, BEIS and other Sub-Committees on matters of relevance to the SMKI arrangements.

This month, the SMKI PMA was presented with the following items:

2. **SMETS1 FOC S1SPKI Certification Practice Statement (RED)** (DCC) The DCC provided the SMKI PMA with an update on the SMETS1 FOC S1SPKI Certification Practice Statement as required by SEC Section L14.
3. **FOC t-Scheme Outcome (RED)** (DCC) The DCC provided the SMKI PMA with an update on the follow-up actions from the most recent t-Scheme audit undertaken by the DCC as required by SEC Appendix AO, and Members noted that t-Scheme certification is now awarded and listed on the t-Scheme website.
4. **SMKI t-Scheme Findings (RED)** (DCC) The DCC provided the SMKI PMA with an update on the follow-up actions following the outcome of the SMKI t-Scheme audit as required by SEC Appendix C, and Members provided feedback.
5. **Key Custodians (RED)** (DCC) The DCC provided the SMKI PMA with an update on Key Custodians, and noted that details on the safekeeping of Keys will be provided at the May SMKI PMA meeting.
6. **TSP Re-Procurement (RED)** (DCC) The SMKI PMA noted the update on the latest position of the re-procurement of the Trusted Service Provider (TSP).
7. **SMKI Recovery Testing & Future Testing Scenarios (RED)** (DCC) The SMKI PMA noted the updates on the outstanding defects from Phase 2 of SMKI testing and provided feedback on the suggested items and timeline for 2021 SMKI testing.
8. **New Draft Proposals and Modification Proposals (GREEN)** (SECAS) The SMKI PMA noted the updates on [DP157 – DP159](#) and agreed that these have no impact on SMKI. However, the SMKI PMA had interest in [DP160 'Certificate Signing Request Forecasting'](#) and requested to be kept informed on this modification.

9. **MP134A 'Use of SMKI Certificates relating to a SoLR event' Proposed Solution (GREEN)** (SECAS) SECAS provided the SMKI PMA with the proposed solution and legal text for [MP134A 'Use of SMKI Certificates relating to a SoLR event'](#), noting that this modification can potentially to be implemented in August 2021 via an adhoc SEC release.
10. **Q4 2020/21 Lookback Report (Jan-Mar) (AMBER)** (SECAS) The SMKI PMA noted the lookback report against the Q4 (January – March) Work Package.
11. **SMKI PMA Risk Register (RED)** (SECAS) SECAS provided the SMKI PMA with proposed updates to the SMKI PMA Risk Register, and Members requested that three more risks are added.
12. **SMETS1 Symmetric Keys (RED)** (DCC) The DCC provided an update on SMETS1 Symmetric Keys and agreed to provide a Certificate Policy Document for the May SMKI PMA meeting.
