## 1. Approval of Previous Meeting Minutes

The Secretary confirmed one set of comments had been received from a Change Board member (RN) on the minutes from the previous Change Board meeting held on Wednesday 24 March 2021. The Change Board **APPROVED** the minutes as modified.

### 3. MP147 'SMKI Full Extract' Change Board vote

The Change Board was invited to perform the final vote on MP147 'SMKI Full Extract'.

SECAS (AB) noted two responses were received in regard to the Modification Report Consultation, both of which were supportive of this change. One respondent had questioned the DCC cost savings that would be achieved if this modification was implemented. AB reported that the DCC has responded a Preliminary Assessment has not been issued as the majority of SEC Parties were happy with the Proposed Solution and an Impact Assessment to establish the costs to increase the capacity of the current process were not being considered as a solution.





The DCC (ST) highlighted one area of concern as part of the Modification Report, highlighting that there will be DCC system impacts to amend the frequency. Someone within the DCC's Programme should have reached out highlighting that a DCC Assessment is required for this change.

SECAS (AB) responded that a discussion had been held with the DCC on this, where it had been confirmed that as these are internal changes, it will not need to be impact assessed. The DCC (ST) confirmed although there are no costs involved, there will be impacts to the DCC's internal systems and to SEC Parties.

SECAS (AB) clarified that only two Parties were identified where impacts could occur, the first Party was not concerned about these impacts with the second Party (a DCC Service Provider) confirming the impacts will be managed internally and implemented as part of a Maintenance Release, not a SEC Release.

No comments were raised, and the Change Board proceeded to vote.

#### Change Board Vote - MP147 decision:

The view of the Change Board is that MP147 will better facilitate SEC Objective (b)<sup>1</sup> for the reasons given in the Modification Report.

The Change Board:

- AGREED that MP147 should proceed to vote;
- AGREED that MP147 should be APPROVED under Self-Governance; and
- PROVIDED rationale for this decision against the General SEC Objectives.

There will now be 10 Working Days for any SEC Party who wishes to refer the Change Board's decision to the SEC Panel to do so. This referral period will close at **5pm** on **Thursday 6 May 2021.** 

If no referrals are received by this date, then MP147 will be implemented on 24 June 2021 as part of the June 2021 SEC Release.

#### 4. MP104 'Security Improvements' Impact Assessment Request

The Change Board was invited to approve the DCC IA request for MP104 'Security Improvements'. No comments were raised.

The Change Board AGREED that a DCC Impact Assessment should be requested for MP104.

#### 5. Use of Microsoft Teams

SECAS (DK) informed the Change Board that a new Microsoft Teams platform is being implemented by SECAS for the Panel and each Sub-Committee including the Change Board. This platform will be where all meeting papers are uploaded to for the Change Board to view, discuss and ask questions within the chat function, to support collaborative working. SECAS advised that within the coming weeks it will circulate to Change Board Members videos and information on how this functionality works and how to use it before it is implemented for full use for the 26 May Change Board meeting.

A Change Board member (AC) highlighted previous problems have been experienced in gaining access to the Teams channel via their external servers. They requested any guidance SECAS has on Microsoft Teams to be sent as soon as possible, in order to address any problems before the next Change Board meeting. Another member (AH) noted issues they had had with connecting for other Sub-Committees and requested if SECAS could work with them to investigate if this was an internal IT issue.

A member (TL) asked if confidential items would still be issued via Egress. SECAS confirmed this would be the case.
