MP210 'RSA forecasts, orders and pay stock charges for Alt HAN Equipment' Conclusions Report – version 1.0

About this document

This document summarises the responses received to the Modification Report Consultation and the decision of the Change Board regarding approval or rejection of this modification.

Summary of conclusions

Change Board

The Change Board voted to **approve** MP210. It believed the modification better facilitates Smart Energy Code (SEC) Objectives (a)¹, (c)² and (h)³.

Modification Report Consultation

The Smart Energy Code Administrator and Secretariat (SECAS) received four responses to the Modification Report Consultation. Three respondents believed that the modification should be approved. They considered the modification better facilitated SEC Objectives (a), (c) and (h). The fourth respondent abstained.

Modification Report Consultation responses

Summary of responses

Three respondents (two Large Suppliers and one Network Party) believed that the modification addresses the issue defined. One respondent, a Large Supplier, stated the modification is an important enabler to ensure all residential consumers that need Alternative Home Area Network (Alt HAN) Equipment to allow for smart functionality, regardless of the size of their Supplier.

The final respondent, the Alt HAN Company, abstained as they believed that the vote was a matter for Relevant Suppliers. They also advised that Alt HAN Co is preparing the necessary contract changes required to give effect to MP210 and the Alt HAN Forum decisions on implementing changes will be contingent on confirmation of the approval of this modification.

Views against the General SEC Objectives

Objective (a)

The Change Board believes that MP210 will better facilitate SEC Objective (a) as the Proposed Solution will facilitate the installation of smart metering systems.

Objective (c)

The Change Board believes that MP210 will better facilitate SEC Objective (c) as installing Alt HAN Equipment will allow consumers to manage their energy consumption via smart metering systems.





Objective (h)

The Change Board believes that MP210 will better facilitate SEC Objective (h) as the Proposed Solution will allow Suppliers' Registered Supplier Agents (RSAs), to forecast, order and procure Alt HAN Equipment on their behalf.
