SMKI PMA Meeting Headlines

SECPMA_44_2003 - Draft Minutes (For Decision)

Draft Minutes from the 44th SMKI PMA meeting held on 20th March 2018 were approved as written.

SECPMA_45_1704_03 – Actions Outstanding (For Information)

SECAS, the SMKI PMA Chair and the DCC provided an update on closed actions since the last SMKI PMA meeting, and discussions took place on several ongoing actions still being progressed.

SECPMA_45_1704_04 - SMKI Repository Testing (SRT) Part 4 Completion - Update (For Decision)

The DCC provided the SMKI PMA with the SRT Part 4 Completion Report and provided an overview of the exit criteria. The SMKI PMA were asked to consider the DCC SRT Part 4 Completion Report and make a recommendation for approval to the SEC Panel at the next meeting. The SMKI PMA AGREED that the SRT Part 4 Completion Report be RECOMMENDED FOR APPROVAL to the SEC Panel.

SECPMA_45_1704_05 – Demonstrating SMKI Recovery in the Product Environment (For Discussion)

The DCC informed the SMKI PMA that the DCC were currently in discussion with a User to participate in test recovery in the production environment. It was confirmed that more planning on details and logistics was needed but the SMKI **NOTED** the update provided by the DCC. It was also noted that a volunteer is currently in discussion with the DCC.

SECPMA_45_1704_06 - SMKI Certificates Leading Zeros (For Information)





The DCC provided the SMKI PMA with a paper outlining DCC remediation actions to address a SMKI-related Severity 2 incident. The incident relates to SMKI Certificates having leading zeros in the signature 'blob' of the SMKI Certificate that subsequently fails validation when latest versions of Java are installed. The SMKI PMA **NOTED** the background and remediation plans from the DCC. The SMKI PMA further agreed that the current Section L governance arrangements for DCC access to the SMKI Repository may need to be amended.

SECPMA_45_1704_07 - Reuse of SMKI for SMETS1 (For Advice)

The DCC provided the SMKI PMA with a presentation on the proposed re-use of SMETS2 SMKI for SMETS1. The SMKI PMA **NOTED** the contents of this update, however, requested more time to review the information provided by the DCC in order to provide comments ahead of the SMETS1 workshop scheduled for the 1st May 2018.

SECPMA_45_1704_08 – Key Custodians Update (For Discussion)

The DCC informed the SMKI PMA about their need to call for nominations for Key Custodians. The SMKI PMA were informed of two new applications that were being reviewed, but also highlighted that more applicants would be welcomed. The SMKI PMA **NOTED** the update provided by the DCC.
