SECPMA_47_1906 – Draft Minutes *(For Decision)*

The Draft Minutes from the SMKI PMA meeting held on 19th June 2018 were approved as written.

SECPMA_48_1707_03 – Actions Outstanding *(For Information)*

SECAS, the SMKI PMA Chair and DCC provided an update on closed actions since the last SMKI PMA meeting, and discussions took place on several ongoing actions still being progressed.

SECPMA_48_1707_03a – Use of SMKI for SMETS1 *(For Information)* **(RED)**

The SMKI PMA were provided an update regarding advice that the Security Sub-Committee (SSC) has requested from National Cyber Security Centre (NCSC) relating to the use of SMKI for SMETS1. The SMKI PMA **NOTED** that the SSC would provide an update once received.
