SECPMA_48_1707 – Draft Minutes (For Decision)

The Draft Minutes from the SMKI PMA meeting held on 17th July 2018 were approved as written.

SECPMA_49_2108_03 – Actions Outstanding (For Information)

SECAS, the SMKI PMA Chair and the DCC provided an update on actions from previous SMKI PMA meetings, and discussions took place on several ongoing actions still being progressed.

SECPMA_49_2108_04 - tScheme Report and Approval (For Decision) (AMBER)

The DCC provided the SMKI PMA with the Independent SMKI Assurance Scheme Report as per obligations under SEC Appendix C paragraph 4.6(c). The DCC also provided the SMKI PMA with its Management Response which addressed the minor non-conformities that had been identified.
