SMART METERING IMPLEMENTATION PROGRAMME: SMART ENERGY CODE (SEC) CHANGES FOR RELEASE 2 GO LIVE

- This letter constitutes a consultation on changes to the SEC related to Release 2 (which involves a number of DCC and SEC Party Systemimpacting changes, including those necessary to support dual band communications hubs). We are consulting on the incorporation into the SEC of a revised DCC User Interface Services Schedule (UISS) and a revised Service Request Processing Document (SRPD). Consequential changes, including a change to Section A of the SEC and changes to the Technical Specification Applicability Tables (TSAT) are set out and the expiry of transitional variations relevant to Release 2 noted.
- 2. At the meeting of the Implementation Managers' Forum (IMF) on 27 September, DCC indicated that it will not be seeking approval for dual band comms hub firmware as part of its submission for Release 2 go-Live on 28 October. We will be writing separately to the SEC Panel and its Testing Advisory Group (TAG) shortly with regards to our expectations on the scope of their decision-making during October in relation to Release 2 testing exit and go-live.

Incorporation of UISS and SRPD in the SEC

- This letter constitutes a consultation on the proposed timing for the incorporation into the SEC of a revised UISS and SRPD for Release 2: redesignating v1.1 of UISS (Annex A of this letter) as Appendix E of the SEC and v1.1 of SRPD (Annex B of this letter) as Appendix AB of the SEC.
- 4. The UISS and SRPD for Release 2.0 were consulted on and baselined through transitional governance and published on the SEC website.¹ Following that process two further clarificatory changes are proposed:

- The UISS Service Reference Variant 6.2.10 stated that the Registered Supplier Agent may access the associated Service Request. However, there is no corresponding permission in GBCS v2.1 and we propose amending UISS v1.1 to remove this reference (this amendment is included in Annex A).
- SRPD clause 15.5(c), which specified DCC requirements when receiving a Sub GHz Alert, needs to align with DUIS clause 3.9.14. We propose amending the relevant clause of SRPD v1.1 to require that the DCC creates a DCC Alert containing the relevant information from the Sub GHz Alert as specified in DUIS (this amendment is included in Annex B).
- As a consequence of the incorporation of the revised UISS v1.1 and SRPD v1.1, we propose to update Section A of the SEC (Definitions and Interpretation) to include definitions for 'Sub GHz Alert' and 'Sub GHz Available Channels' (Annex C of this letter).
- We propose incorporating the amended UISS v1.1 and SRPD v1.1 into the SEC, and making the changes to Section A of the SEC effective, on 28 October 2018² (or, if the Secretary of State considers it necessary, within one month thereafter).

Technical Specification Applicability Tables (TSAT)

- 7. Release 2 introduces the updated versions of the Technical Specifications: SMETS2 v3.0 and CHTS v1.1 as well as the updated versions of GBCS v2.0 and v2.1. These documents have already been incorporated into the SEC. We propose updating TSAT (Schedule 11 of the SEC) on the basis of there being 12 months from Release 2 go-live for industry supply chains to be cleared of previous specification Devices. This gives rise to the following TSAT amendments:
 - Installation, Maintenance and GBCS Applicability Start Dates (on both GBCS v2.0 and GBCS v2.1) for SMETS2 v3.0 and CHTS v1.1 set as the Release 2 go live date (planned as 28 October 2018);
 - the Installation Validity Period End Date for SMETS2 v2.0 set as 27 October 2019 (Release 2 date + 12 months); and
 - the Installation Validity Period and Maintenance Validity Period End Date for CHTS v1.0 set as 27 October 2019 (providing a 12-month window during which existing CHTS v1.0 Communication Hubs must be upgraded to v1.1, and new Communications Hubs being installed must be compliant with CHTS v1.1).
- 8. The changes outlined above are included in the extract of the TS Applicability Tables (Schedule 11 of the SEC) for re-designation on 28 October 2018 (or, if

the Secretary of State considers it necessary, within one month thereafter), in **Annex D** of this letter.

Transitional Variations

9. On 1 February 2018 the Secretary of State issued a direction making various changes to the SEC to facilitate the delivery of Release 2.0.³ Paragraph 4 of that direction included several transitional variations that were to remain in place until Release 2.0 go-live (reproduced at **Annex E** of this letter). These transitional variations will remain in place until 31 October 2018 when the power used by the Secretary of State to make the transitional variations (Section X3 of the SEC) expires.

Draft Direction

10. The draft text for the direction making the changes set out above is provided at **Annex F** of this letter.

Consultation Responses

11. We would welcome views on:

- i. The proposed designation date of 28 October 2018 (or, if the Secretary of State considers it necessary, within one month thereafter) for the incorporation and effective date of the revised UISS v1.1, the revised SPRD v1.1 and consequential changes to Section A.
- ii. The proposed designation date of 28 October 2018 (or, if the Secretary of State considers it necessary, within one month thereafter) for the incorporation and effective date of the revised TSAT.

ANNEX E

Transitional Variations related to Release 2.0 (extract from direction dated 1 February 2018)

4. Pursuant to Section X3.6 (Provisions to be Effective Subject to Variations), the Secretary of State hereby directs that:

(a) notwithstanding that DUIS v2.0 has been designated and incorporated into the SEC, no Party to the SEC shall be entitled to exercise the rights set out in DUIS v2.0, nor obliged to comply with the obligations set out in DUIS v2.0;
(b) notwithstanding that MMC v2.0 has been designated and incorporated into the SEC, no Party to the SEC shall be entitled to exercise the rights set out in MMC v2.0, nor obliged to comply with the obligations set out in MMC v2.0;
(c) notwithstanding the re-designation of the CHTS v1.1 and CHTS v1.2 documents, Section F5 (Communications Hub Forecasts and Orders) and

Section F6 (Delivery and Acceptance of Communications Hubs) shall apply so that:

i. the DCC shall not be obliged to make Dual Band Communication Hubs available for delivery;

ii. no Party shall be entitled to order Dual Band Communication Hubs⁴;

iii. in the event of a delay to either or both of: (A) the date on which dual-band Test Communications Hubs are (or are to be) made available for use in user integration testing (referred to in the LC13 Plan as 'UIT DBCH Commence'); and/or (B) the date upon which Release 2.0 functionality is (or is to be) released into DCC Live Systems (referred to in the LC13 Plan as 'R2.0 Code into Live'), in each case as compared to the dates set out in the LC13 Plan as at the date of a Party's Communications Hub Forecast and/or Communications Hub Order, then the Party may request a change to reduce the number of Dual Band Communications Hubs that are included within such Communications Hub Order and/or Communications Hub Forecast; and the DCC shall take reasonable steps to accommodate the requested reduction and to revise such Communications Hub Order and/or Communications Hub Order and/or Communications Hub Order and/or Communications Hub Order and/or Communications Hub Forecast; and the DCC shall take reasonable steps to accommodate the requested reduction and to revise such Communications Hub Order and/or Communications Hub Forecast accordingly; and

(d) notwithstanding the re-designation of the CH Handover Support Materials and the CH Installation and Maintenance Support Materials and in light of the transitional variations set out in paragraph (c) above as well as the LC13 Plan milestone 'First batch of production DBCH available', the DCC shall make a limited number of Dual Band Communications Hubs available for Parties to order (and shall deliver Dual Band Communications Hubs pursuant to any such orders) in accordance with such reasonable terms of general application and in timescales as the DCC may from time to time specify on its website.

ANNEX F

Draft Release 2.0 Direction

This direction is made for the purposes of the smart meter communication licences granted to Smart DCC Ltd under the Electricity Act 1989 and the Gas Act 1986 (such licences being the "**DCC Licence**") and the Smart Energy Code designated by the Secretary of State pursuant to the DCC Licence (such code being the "**SEC**").

Words and expressions used in this direction shall be interpreted in accordance with Section A (Definitions and Interpretation) of the SEC.

Re-designation of SEC Schedules & Subsidiary Documents, and consequential changes to Section A

- Pursuant to Condition 22 of the DCC Licence and Section X5 (Incorporation of Certain Documents into this Code) of the SEC, the Secretary of State directs that, with effect from {xx}, the TS Applicability Tables previously designated and incorporated into the SEC as Schedule 11 of the SEC are hereby re-designated and incorporated in the form set out in Annex {x} of this direction.
- 2. Pursuant to Condition 22 of the DCC Licence and Section X5 (Incorporation of Certain Documents into this Code) of the SEC, the Secretary of State directs that, with effect from {xx}, the DCC User Interface Services Schedule, previously designated and incorporated into the SEC as Appendix E of the SEC is hereby re-designated and incorporated in the form set out in Annex {x} of this direction.
- 3. Pursuant to Condition 22 of the DCC Licence and Section X5 (Incorporation of Certain Documents into this Code) of the SEC, the Secretary of State directs that, with effect from {xx}, the Service Request Processing Document, previously designated and incorporated into the SEC as Appendix AB of the SEC is hereby re-designated and incorporated in the form set out in Annex {x} of this direction.
- 4. Pursuant to Condition 22 of the DCC Licence and Section X5.6 (Supplementary Provisions) of the SEC, the Secretary of State directs that, with effect from {xx}, Section A.1 (Definitions) of the SEC is hereby amended to include the definitions set out in Annex {x} of this direction.

For the avoidance of doubt such re-designation of the TS Applicability Tables, the DCC User Interface Services Schedule and the Service Request Processing Document shall be without prejudice to anything done under the DCC Licence or the SEC on or after these documents first being designated, or to the continuing effectiveness of anything done under these documents prior to their re-designation (which shall have effect as if done under the re-designated documents).

This direction is also being notified to the SEC Administrator and an updated version of the SEC to reflect these changes will be available on the SEC website in due course.
