### **Change Board discussions**

The unanimous view of the Change Board is that SECMP0019 better facilitates General SEC Objective(s) (a), (c) and (d) and should be approved.

#### **Change Board discussions**

Change Board members considered that, although they were supportive of the modification, they had concerns that Suppliers may struggle with applying the correct label if they undertook the new standardised list.

A Change Board Member raised the issue of the list's non-mandatory status. They questioned the effectiveness of the modification where there was a choice to act on the change or not despite the time, effort and resources that has gone into the Modifications Process to reach this outcome. This opinion was seconded by another Change Board Member, raising what assurances could be given to ensure the list was properly maintained, updated and enforced by SECAS.

A Change Board Member mentioned that, despite the issues raised, they would be supportive of the modification. They would want to see it implemented, so long as there is a high uptake of Suppliers choosing to adhere to the standardised list set out on the website.

Finally, a Change Board Member raised concerns over the costing of the modification. Although the cost of the proposed solution is £1,200, they questioned why this nonmandatory list option cost as little as this while the mandatory list option was quoted at £432,000 - £622,000 for seemingly little change to the modification detailing. Given that the cost was very influential over the choice to make the list non-mandatory, the member wanted future modifications to include a specific financial breakdown as to the reasons and causes of expense in solution designs. They noted that they would have preferred a mandatory list and expressed concerns that this modification's solution had been weakened due to the high costs to amend the DCC Systems.

#### **Views against the General SEC Objectives**

#### Objective (a)<sup>1</sup>

The majority view of the Change Board is that the modification better facilitates General SEC Objective (a), as it will increase efficiency through avoidance of customer service issues related to different ALCS naming conventions.

A minority of the Change Board believe that this modification is neutral against General SEC Objective (a) due to the solution being non-mandatory and therefore not ensuring the proposed efficiency gains.

#### Objective (c)<sup>2</sup>

The **majority** view of the Change Board is that this modification will better facilitate General SEC Objective (c) through improving the Energy Consumer experience by having a clear and consistent means of identifying the ALCS across different energy Suppliers.

A minority of the Change Board believe that this modification will be neutral against General SEC Objective (c), citing that this will only apply depending on the number of Suppliers that uptake this solution, due to the solution being a recommendation rather than enforced.

#### Objective (d)<sup>3</sup>

The **unanimous** view of the Change Board is that this modification will better facilitate General SEC Objective (d) through the Change of Supplier process being easier and less complex to administer. This is due to consumers being less likely to be confused between the different naming conventions used between different Suppliers, and the gaining Supplier better understanding what is attached to each ALCS or HCALCS.

For the avoidance of doubt, the Change Board believe that SECMP0019 is neutral against all other General SEC Objectives.


